Regulation on Intellectual Property in “Biznesi” College was drafted in accordance with the Decision of the High Teaching and Scientific Council, based on Law no. 04 / L-037 “On Higher Education in the Republic of Kosovo”, the Statute of the College Article 81; on all other applicable legislation and which has been approved by the Decision of the High Scientific Teaching Council dated 29 January 2021

## INTELLECTUAL PROPERTY REGULATIONS

### Article 1

Intellectual property according to this regulation means as follows:

1. Registration of intellectual property
2. The way of preserving scientific works
3. The time period determined for the preservation of the property right
4. Copyright
5. The Rights of the College

### Article 2

Biznesi College in addition to this regulation will also abide by the law on Intellectual Property (<https://gzk.rks-gov.net/ActDocumentDetail.aspx?ActID=2643>) and the Law on Copyright and Related Rights: <https://gzk.rks-gov.net/ActDocumentDetail.aspx?ActID=2787>

### Article 3

Elements of copyright include;

1. co-authors and authors of the joint work;
2. the content of the property rights of the author and the right to special compensation for private or other own reproduction;
3. the relationship between the copyright and the ownership right over the copy of the work;
4. copyright restrictions, including the inclusion of restrictions;

5. calculating the beginning and ending effect of the duration of copyright protection, as well as the transfer of copyright;

#### Article 4

1. Copyright is an indivisible right of a work, which belongs to the author as the subject of intellectual property for the protected work.

2. Copyright contains:

2.1. exclusive personal authorizations to protect the inviolability of the author's work and the personality of the author, as follows: the moral rights of the author;

2.2. exclusive property authorizations to protect the property interests of the author, as follows: copyright for the author;

2.3. other authorizations, as follows: other copyrights.

#### Article 5

Copyright belongs to the author with the very fact of creating the work

#### Article 6

1. The works of the author are the original intellectual creations in the field of science and are fully respected by the College based on copyright law.

#### Article 7

1. The completed, unfinished scientific works of the author, the constituent parts of the work, the title of the author's work, which are in themselves original intellectual creations, enjoy protection just as the work itself.

2. It is not allowed to use as a title of the work a title which has been previously used for the same type of work, if such a title causes confusion regarding the authorship of the work.

#### Article 8

Works involving plagiarism will be canceled by the College and exclusionary measures will be taken by Biznesi College.

#### Article 9

The author has the exclusive right to be recognized and marked as the author of the work. 2. The author has the right to decide whether his authorship should be indicated by name, nickname or sign.

#### Article 10

The right to the integrity of the work

The author has the exclusive right to oppose any distortion, or other interference with his work, as well as any exploitation of his work, if such interference could prejudice his creative reputation and respect.

#### Article 11

The right of use and its forms

1. The author has the exclusive right to use the property of his work in any form, as well as to allow or prohibit other persons from using his work, unless otherwise provided by the law.

#### Article 12

1. The author's work can be used in material, non-material and modified form.

#### Article 13

Right to distribution

The right of distribution is the exclusive right of the author to authorize or prohibit the circulation of the original work or copies of his work through the sale or any other form of transfer of ownership, including their offering to the public for such purpose.

#### Article 14

Biznesi College drafts agreements with the author for the publication, use and distribution of his scientific works, books, scientific essays and other publications as well as the sale and compensation.

#### Article 15

Biznesi College consults with the author and seeks his consent for the republishing of the scientific book, scientific paper or scientific essay or any other form of paper.

#### Article 16

Teaching

Utilization of foreign literature

The College will enter into agreements with authors for the use of their book, their scientific work, and other forms of need for extensive use of authorial work.

#### Article 17

This regulation enters into force on the day of signing by the Dean of Biznesi College.
